**I understand the following:**

1. Tuition MUST be paid by the 10<sup>th</sup> of the month due or a late fee of \$25.00 will be charged.
2. If tuition is in arrears after 30 days, the school reserves the right to withhold services, until satisfactory arrangements have been made with the Principal.
3. **\*\*\* REGISTRATION FEE AND THE 1<sup>ST</sup> MONTH TUITION PAYMENT ARE NON-REFUNDABLE. \*\*\***  
Reimbursements for tuition beyond the first month paid will be given to those who withdraw according to the amount paid, less the time spent in school.
4. **AS A PARISHIONER:**
  - A. I will attend Mass faithfully and see that my children do the same.
  - B. I will support my parish by using Sunday Envelopes, with a minimum contribution of \$12.00 per week. (If it is not possible to meet these requirements, it will be necessary to discuss this with the Pastor of your co-sponsoring Parish.)
  - C. If I do not meet the requirements outlined above, my tuition will be raised to the NON-PARISHIONER rate.
5. I must meet the minimum obligations regarding the mandatory HSA fundraisers.
